Help for Historic District Home Owners

If you live in the Kensington Historic District (see www.TOK.MD.gov), you have the opportunity for free consulting on your home projects. All residents are encouraged to talk to planners at the Historic Preservation office in Silver Spring as you FIRST consider changes to your property. These planners are available to work with you to help make your project approvable by the Historic Preservation Commission. You can even bring your ideas to the Commission itself for a preliminary review to get their input. This will make the process easier. Remember, all exterior changes require a Historic Area Work Permit (HAWP).

If you spend (in one calendar year) over \$1000 for restoration OR maintenance (paint, new roof), you can get a tax rebate the following year. Keep your receipts, take before and after pictures, apply for a HAWP if needed, and apply by April. (See www.mcparkandplanning.org/historic, or call 301-563-3400.) These tax credits are meant to support the

preservation of the entire Historic District and therefore are also available to those whose homes might not be considered historic individually.

For more help, review the guidelines in the Vision of Kensington, available in the Town office (open 8 to 4). A draft copy of guidelines applicable to the entire county is available on the Montgomery County Park and Planning website noted above.

Warner Circle Updates

The following is the text of the letter sent by Citizens United to Save the Circle (President Duane Thompson), the Kensington Historical Society (President Julie O'Malley), and the Kensington Land Trust (Treasurer Jim Engle).

[We received a reply from Director of Parks, Mary Bradford. She referred to the unique purposes of this RFP and the ongoing efforts of the Finance and Stewardship Departments to fine tune the evaluation process, and further stated that our "specific comments on the process have been passed on to the relevant staff for consideration as they refine this process." We look forward to continuing collaboration with the Parks and Planning Department staff, and to their public presentations providing opportunity for community input.]

Dear Chairman Hanson:

The undersigned community organizations are writing to request certain procedures with regard to the pending RFP applicant review process which we believe will help achieve the selection of the best proposal for Kensington, the surrounding community, and the County.

Our organizations have worked hard to preserve Warner Circle and fully support the efforts of the County and Planning Board to accomplish that goal. Citizens United to Save the Circle is comprised of residents whose homes are in the immediate vicinity of Warner Circle, as well as throughout the town and neighboring communities. The Kensington Historical Society (KHS) is a well established organization whose membership extends beyond the town limits and whose efforts placed the Kensington Historic District on the National Register in 1980. The Kensington Land Trust, incorporated in 1992 to help preserve open space in Kensington, has worked actively with the KHS to protect and preserve historic Kensington, especially Warner Circle.

The Warner property is a central feature of the Town of Kensington, and its future use is of vital importance to the Town's residents, as well as to the greater community. From the beginning, our Town government and our organizations have worked to foster a collaborative and cooperative relationship with the County and to provide timely support and information with regard to community resources, interests and concerns. This letter is submitted in the same cooperative spirit.

We appreciate the Planning Board's good-faith efforts to act in the best interests of the Town, but we remain concerned about the clarity and details of the source selection process, and more generally, about options for community participation. One resident's recent remark seems to capture the concerns of many: "We have more opportunity to formally comment on a neighbor's planned fence installation than we do on this project, the single most important project in the Town's history."

To be sure, having two community representatives on the proposal evaluation team is extremely important to us, so we thank you for granting the Town's request for this representation. At the same time, we wish to express our strong concerns regarding the pending RFP applicant review process. We do understand that this project presents a unique situation. As you noted in your May 20th letter to Mayor Fosselman, this is "not the typical RFP." It does not call for the standard bi-county regulations for procurement, but for a process that will be customized to accommodate the particular needs of this project, including the possibility of a public/private partnership. As the County forges new

ground with this special project, we urge that you strike a balance between the County's procedural requirements and the public's right to be informed.

As you are aware, our community is engaged and informed on most of the issues surrounding this project. As in most cases, the affected community constitutes an important customer base whose positive, proactive involvement is essential to facilitate a successful outcome. We are also aware that a "lack of community acceptance" is often cited in the inevitable post mortem of failed public projects. Please know that we stand firm in our commitment to help ensure that this project is successful for all involved. With this in mind, we ask that you implement the following requests, which we believe will lead to the selection of the best use for all concerned.

Prior to review of respondent proposals by the evaluation team, provide a presentation to the Town's citizens, clarifying the steps and options involved in the selection process as well as the overall objectives / approach of the project, allowing for questions from the audience. This presentation should provide an explanation of the entire process, such as a description of the source selection process; the decision process, including legal authority; applicable public regulations; anticipated timeframe; decision milestones; any planned public meetings; and subsequent procedures and actions.

Allow community organizations and residents to present concerns and interests to the Planning Board and / or evaluation team at a public meeting held prior to the review of proposals. We believe that newly-appointed Planning Board members as well as the evaluation team would benefit from hearing the "citizens' perspective" in addition to briefings by Planning Board staff

Conduct a public hearing or meeting on the conceptual elements of the proposals following initial evaluations and prior to any formal recommendations to the Planning Board. Given the unique aspects of this public project, we believe a conceptual presentation would serve to keep the community appropriately informed without compromising any specific proprietary information. This could be accomplished by requiring respondents to provide a concept abstract for public review as an addendum to the RFP.

In closing, we want to emphasize that we greatly appreciate the tremendous commitment and effort put forth by M-NCPPC to preserve this important legacy resource for the County; and we understand and appreciate the benefit to all of our mutual cooperation and continuing dialogue. We, as representatives of several of Kensington's citizen groups, remain at your disposal to respond to suggestions for making the RFP as transparent as possible. Providing for citizens' input will surely result in the selection of the best use, which use will be fully supported by the Town's residents.

IN MEMORIAM

Marshall Gooding

A long-time resident of Kensington and member of the Historical Society, William Marshall Gooding, age 90, passed away on July 7th. Mr. Gooding's family dates back at least three generations in Kensington and his family tree extends to other long-time town and area residents. His grandfather moved to Dupont Avenue around 1912 and he and his family later lived in the house. He returned to Kensington after his World War II service and lived again on Dupont Avenue with his wife, Dorothy (Jones) Gooding and his two children, just down the street from where he had lived as a teenager. The late Mrs. Gooding, for whom the Council Room at Town Hall is named, served on the Town Council and for many years as Clerk Treasurer. She was from a family with a long and connected history in town as well. Mr. Gooding enjoyed sharing family and historical information about Kensington and was involved in and concerned about issues facing the town. He provided the Historical Society with an oral history of his life in Kensington and shared many tidbits of what life was like in town over the last century.
